### As Minnesota schools begin to transition to the new Ed-Fi reporting system, which will eventually replace MARSS A & B files submission, it will be important to verify the data quality from the new reporting system with the old.

# Overview



During the 2019–2020 school year many schools will be using the new Ed-Fi system for the first time and will be required to verify their data quality by using an MDE-provided tool (portal/report).

This tool can be found by logging into your MDE Staging Portal

NOTE: PRIOR TO LOGGING IN TO THE STAGING PORTAL YOU MUST SUBMIT THE APPROPRIATE DATA FIRST



### Sequence is important

- Submit your data via the Ed-Fi API
  - Typically done using <u>Minnesota Counting All</u> <u>Students – Update Grade</u>
    - Submit one grade level at a time
      - May submit "All Grades" at once if school population is small (less than 200 students)
    - Note: this is best practices even if Near Real Time is enabled in Ed-Fi Settings
    - You will be prompted to work through any errors before continuing to the next step

After Ed-Fi submission is clean, then create a MARSS A & B file and upload



- Uploading the MARSS A & B file will trigger a new report comparing that MARSS A/B file submission with current data at MDE available via Ed-Fi
- Now you can log in to see the comparison.

Before you upload your files to the Minnesota Department of Education, most file generation options in the JMC Minnesota module will generate an error report for you. This means you can correct nearly all issues with your data before uploading your files to MDE.
