  - StudentEducationOrganizationAssociation (SEOA)
- Piloting Ed-Fi connectivity and new Ancestry data




- **▶** 2019–2020
  - Schools have volunteered to participate
    - Limit to 20 JMC clients for 2019-20 to keep support at an acceptable level for this beta test year
  - Schools will be collecting and reporting new Ancestry data for the first time



- > 2019-2020
  - Includes Ed–Fi 3.1 conversion
  - Includes conversion of MARSS A & B file data elements into the Ed-Fi model

      - StudentEducationOrganizationAssociation

      - Calendar
      - Student Program Associations (14 types)

### MDE Timeframe for 2019-20 On-Boarding

- May October 2019 MDE checklists sent to districts, work on checklists, on-boarding
  - Clients will need to sign up for individual on-boarding sessions with JMC Tech Support prior to working in staging environment
- November December 2019 districts working in staging environment
- January March/April 2020 districts working in production environment



### MDE Timeframe for 2019-20 On-Boarding

- May June 2019
  - Tara Chapa (MDE) will send out
    - Training Schedule
    - MDE training videos
    - Documentation
      - Setting up vendors with credentials
        - Key and Secret



### MDE Timeframe for 2019-20 On-Boarding

- June- August 2019
  - Contact Eric Doyle (eric@jmcinc.com) to get scheduled for on-boarding session with JMC
    - Prior to On-boarding schools will need to watch
      - JMC Training Videos

        - Eric Doyle will indicate which videos need to be viewed and any other pre-qualifications needed prior to on-boarding

- September October 2019

    - Thursdays for JMC clients, AM and PM sessions
    - JMC rep will be in attendance



- November December 2019
  - districts complete staging by end of December
  - Weekly MDE webinars with Tara Chapa & Marilynn Loehr
    - Thursdays for JMC clients, AM and PM sessions
    - JMC rep will be in attendance
  - Complete MARSS / Ed-Fi Comparison Report prior to moving into production
- January March/April 2020
  - districts move into production
  - weekly meetings continue

### MN Counting All Students



- > 2020-2021
  - MDE wants 90% of MN schools to participate with Ed-Fi submissions by 20-21
  - Includes conversion of MARSS A & B file data elements into the Ed-Fi model
  - Many schools will STILL be collecting and reporting new Ancestry data for the first time

### MN Counting All Students



- Future
  - At some point, MARSS A & B files will no longer be accepted by MDE
    - Will only accept via Ed-Fi processes

## MN Counting All Students



- Future
  - Additional MDE Data Collections via Ed-Fi are in the works
    - MCCC
    - Assessment
    - GRR
  - Double Line Partners working with MDE now, they hope to have something mapped out in fall 2019
  - Probably more data collections converted to Ed-Fi down the road
    - Perkins
    - STAR
    - Early Education
    - DIRS

All Minnesota state reporting options are contained in the JMC Minnesota module and include options for MARSS, MCCC, Early Education Student, Perkins, STAR, and Graduation Standards reporting. Before you upload your files to the Minnesota Department of Education, most file generation options in the JMC Minnesota module will generate an error report for you. This means you can correct nearly all issues with your data before uploading your files to MDE.
