CAS Near Real Time

Near Real Time submission allows you to have data automatically submitted any time you edit a student. Near Real Time processing can be enabled any time after initial Start Year batch processing has been completed

CAS Near Real Time On-boarding



- Make sure you have “on-boarded” for the new school year before enabling Near Real Time
 - Minnesota – Counting All Students – Start Year
 - All tabs

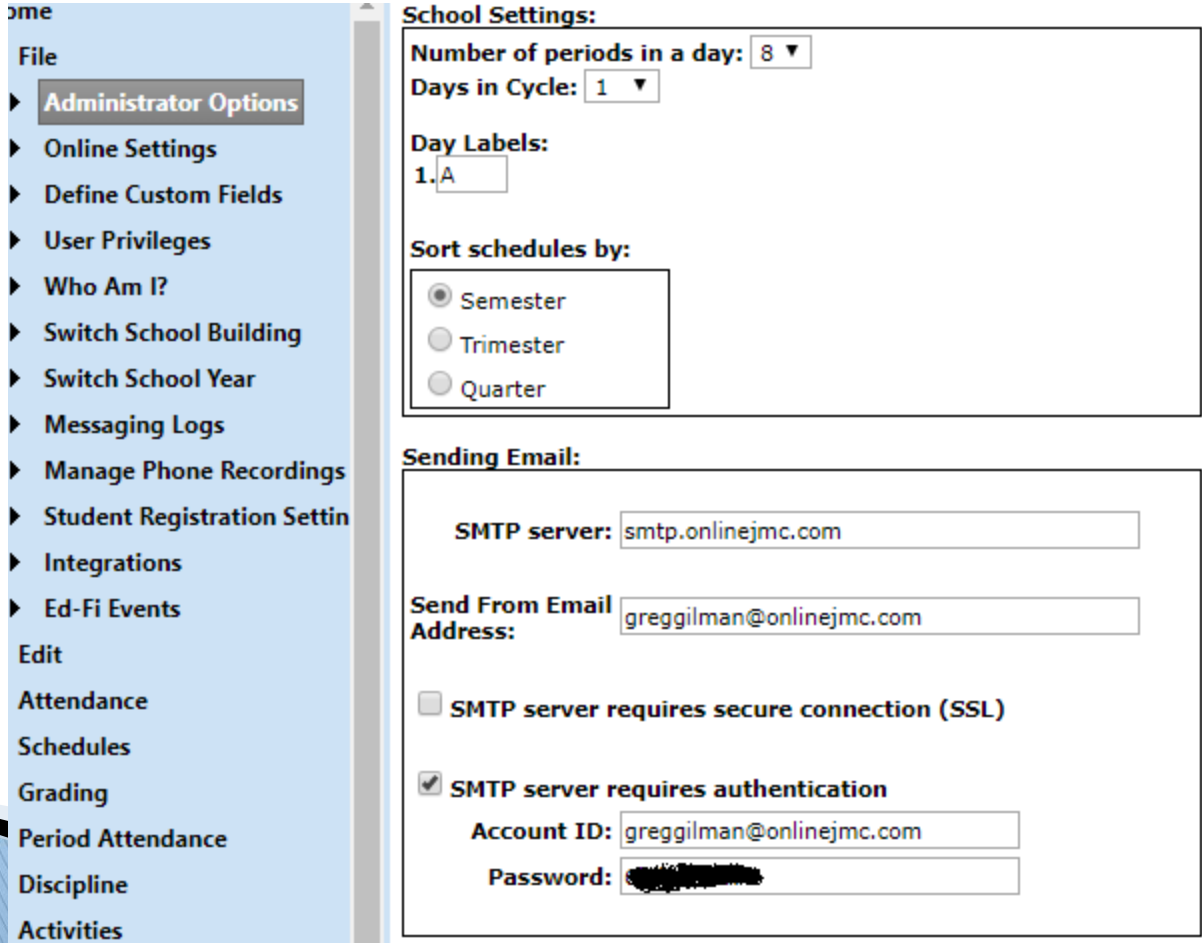

Near Real Time Setup

- Make sure you have finished Start Year processes first
- File – Administrator Options
 - Ed-Fi Settings
 - Enable Ed-Fi Interchanges in Near Real Time
 - Ed-Fi Near Real Time Error Notification Email Address
 - SMTP Settings
 - Acquire from Eric Doyle (eric@jmcinc.com)

CAS Near Real Time

CAS Near Real Time

Almost immediately upon enabling Near Real Time there can be events processed that result in errors.

The error messages will look very similar to what you might see during batch processing, however they will be sent to the designee via email instead of showing up immediately on the page in a summary report.

Generally, the client will only see errors in the report, not processes that ended successfully.

CAS Near Real Time

Email with Errors – Example

Issue

- Possible overlap in claim to student
- Student may have transferred out of your district – drop student correctly?

Solution

- If issue is with your data, fix and resubmit
- If issue is with another school district's data, contact them and have them fix and resubmit

CAS Near Real Time

On-boarding - make sure error counts get to zero

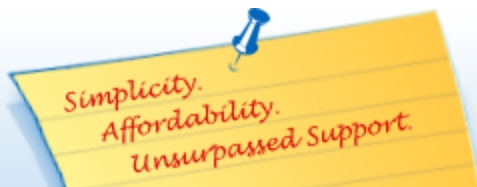

All Minnesota state reporting options are contained in the JMC Minnesota module and include options for MARSS, MCCC, Early Education Student, Perkins, STAR, and Graduation Standards reporting. Before you upload your files to the Minnesota Department of Education, most file generation options in the JMC Minnesota module will generate an error report for you. This means you can correct nearly all issues with your data before uploading your files to MDE.
