Career Education 2018–19 comprised of three main components:

- 1. Career and Technical Education (CTE) as part of the Carl Perkins Funds
- 2. College and Career Ready (CCR) associated with both the Technical Incentive Grant
- 3. New Skills for Youth Grant.

Previously CTE data was collected via an Excel spreadsheet (CTEERS)

- Starting 2018–19 submit CTE data from JMC directly to WISEdata.
- CCR data for both grants are new projects in WISEdata as of the 2018-19 school year.

All public schools applying for Carl Perkins Funds should submit CTE data.

CTE data should be submitted for ALL public school students taking CTE courses in grade levels 9-12.

- You will only submit the student CTE Program Association data when:
- student is a CTE Concentrator in the reporting year
- OR
- student participates in Career Education programs that are not associated to a course OR
- student is identified as a State Endorsed Regional Career Pathway Type participant/completer.

A CTE Concentrator is a secondary student

- identified as a concentrator if he or she completed a minimum of two CTE courses within a chosen pathway and is enrolled in a continuing CTE course in that pathway for the reporting year
 - <u>OR</u>

• A concentrator may also be a student who has completed three CTE courses (or more) within a chosen pathway and is not enrolled in any CTE courses in the reporting year.

Who is a CTE Participant? A student in grade 9–12 taking a CTE course in the current reporting year.

•No 'Participation' flag collected from districts. Participation will be identified from student section associations to CTE courses.

•If student only Participant but not Concentrator, do NOT submit student CTE Program Association for Concentration details.

•If student is enrolled in a CTE course for current year, submit Roster records for the CTE course(s): student and staff section associations, grades, and program data for programs not associated to courses.

CTE Concentrator

Long View – DPI will autocalculate based on course based and non course based records submitted via WISEdata

For 18–19, JMC users will manually create a CTE Concentrator record as program History record (student data page). Program History record creation is also discussed in Video 4 of this series
