CAS Near Real Time vs. Batch Processing

- Batch Processing is any time you have to push a button to send data to MDE
 - Minnesota – CAS – Start Year
 - Minnesota – CAS – Update Grade
 - Minnesota – CAS – Update Student
 - Minnesota – CAS – Delete Student
- Near Real Time submission allows you to have data automatically submitted any time you edit a student. Near Real Time processing can be enabled any time after initial Start Year batch processing has been completed

CAS Near Real Time vs. Batch Processing

Near Real Time Setup

- Make sure you have finished Start Year processes first
- File – Administrator Options
 - Ed–Fi Settings
 - Checkbox to enable
 - Email address for error messages
 - SMTP Settings
 - Acquire from Eric Doyle

CAS Near Real Time vs. Batch Processing

Near Real Time and Batch Processing are Complimentary Parts of the Ed-Fi Model

- Near Real Time attempts to get all changes submitted on the fly
 - Advantage – prompted to work on errors throughout the school year
 - Fix immediately, closer to data entry
 - Should make it easier to figure out errors
 - Errors will show up in email instead of automatically on the page like for batch processes
 - Shortcomings – near real time may not catch all changes

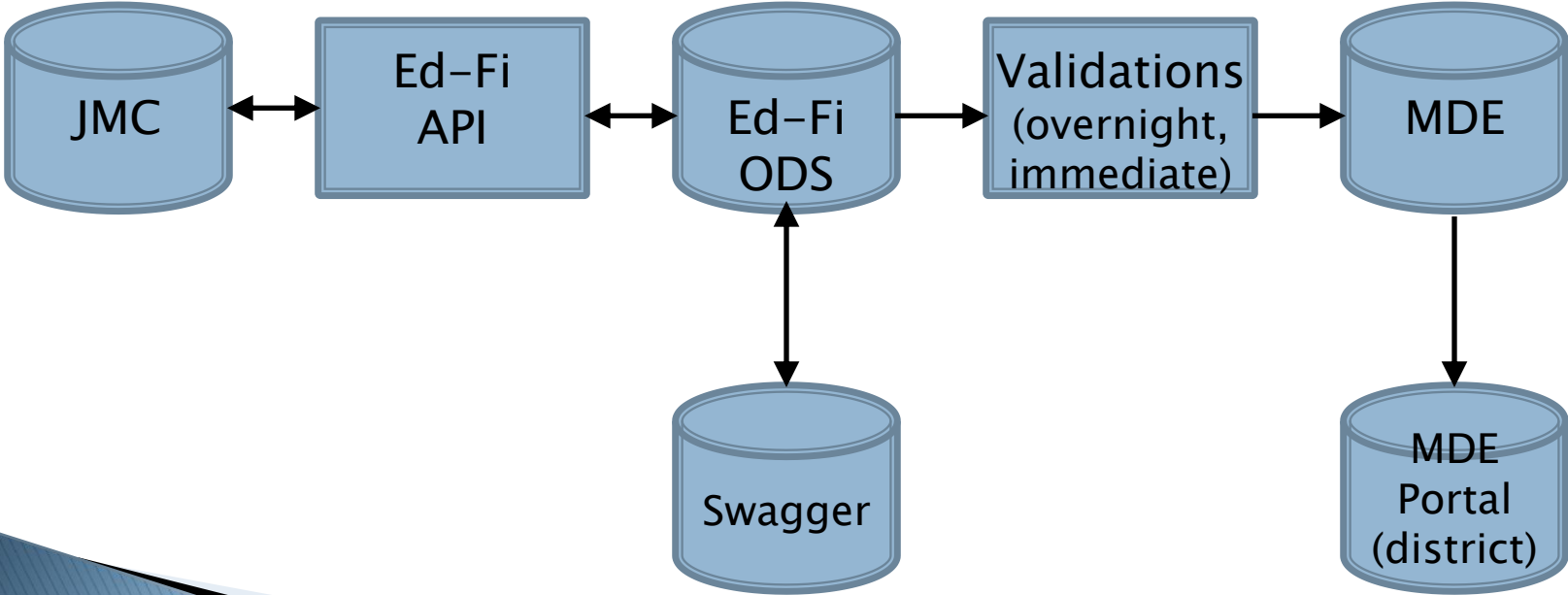
CAS Near Real Time vs. Batch Processing



Near Real Time and Batch Processing

- Batch Processing
 - Weekly is not a bad idea (resynchronize)
- Batch Processes should still be used to resynchronize data prior to deadline, even if Near Real Time is enabled
 - Two Weeks, fix errors
 - One week, fix errors
 - Resynchronizing (batch processing) may flush out additional errors that near real time does not

CAS Near Real Time vs. Batch Processing

Make a point to log in to MDE portal regularly throughout the year

- Minimum – Weekly
- Portal will contain L2 errors which do not show up in either Near Real Time OR Batch Processing

Actively work to correct L1 AND L2 errors on a regular basis

Do not wait until the deadline is near to work on errors!

All Minnesota state reporting options are contained in the JMC Minnesota module and include options for MARSS, MCCC, Early Education Student, Perkins, STAR, and Graduation Standards reporting. Before you upload your files to the Minnesota Department of Education, most file generation options in the JMC Minnesota module will generate an error report for you. This means you can correct nearly all issues with your data before uploading your files to MDE.
