WISEdata Updates 19-20

Overview

- ▶ All of JMC's WISEdata (Ed-Fi) processes have been updated in accordance with the latest Ed-Fi V3.1 update - *released as build 080219*
- ▶ New Enrollment History in JMC
- ▶ SSAs now allow for primary and non-primary enrollments
- ▶ New Program History record types for studentSchoolFoodServiceProgramAssociation, studentLanguageInstructionProgramAssociation

WISEdata Updates 19-20

All of JMC's WISEdata (Ed-Fi) processes have been updated in accordance with the latest Ed-Fi V3.1 update

- *Extensive Update*

- Shuffling attributes between resources
- Types and descriptors merged
- State-specific extensions to resources handled better
 - no more SSAWE
 - Now part of SSA extensions now

WISEdata Updates 19-20

New Ed-Fi version fixes some older issues

- Battling Student resources between districts
 - now moved to new Student Education Organization Association (SEOA) resource
 - SEOA is demographic data
 - Gender
 - Race/ethnicity
 - Languages
 - Other
 - Each school can now submit their own version of student demographic (SEOA) data

WISEdata Updates 19-20

SSAs now submitted via JMC (Enrollment History)

- ▶ Allows for multiple spans of enrollment per student
- ▶ SSA no longer sent from raw attendance data
- ▶ Enrollment History mostly maintained through drop/add/re-enter
- ▶ Allows for each span to have unique values for all fields, e.g. Enrollment Type
- ▶ See presentation/video for Enrollment History

WISEdata Updates 19-20

SSAs now allow for primary and non-primary enrollments (enrollment history)

- ▶ Fixes existing issue where only one primary enrollment permitted even if student attending more than one school
 - Example 1: student taking coursework in multiple public schools
 - Example 2: parent placed private
 - attends private school
 - receives special education services from public school
 - Example 3: enrollments in two different calendars, same school

WISEdata Updates 19-20

Exclusions for submitting Non Primary Enrollments

- ▶ Primary enrollment at public school and non-primary enrollment at choice school
- ▶ Primary enrollment at private school and non-primary enrollment at public school (except parent placed private)
- ▶ Students primarily homeschooled taking one or two classes at public school
- ▶ Students attending CCDEB, DOC, DHS for one or two classes
- ▶ Students age 0-2

WISEdata Updates 19-20

New Program History record types

- ▶ studentSchoolFoodServiceProgramAssociation
 - Free/Reduced lunch status
 - Will be derived from existing JMC lunch status records
- ▶ studentLanguageInstructionProgramAssociation
 - Only required for specific use cases
 - See SLIPA use cases document from WI DPI

WISEdata Updates 19-20

Update to Special Education History (SSEPA)

- ▶ Parentally Placed Private
 - No longer in SSEPA
 - Now in Student School Association (SSA)
